## ARTS & CRAFTS FAIRE

### RULES FOR ENTRIES AND JUDGING

1. All participants must be members of Epsilon Sigma Alpha International and the California State Council.
2. All interested individuals must file an entry form with the Association of the Arts Chairman by the deadline of May 1 in order to participate.
3. There will be a \$3.00 non-refundable registration fee for each item submitted. This money will be used for supplies and awards. Please make checks payable to the current Association of the Arts Chairman.
4. All items must be checked in prior to judging on Friday evening of convention, by 4:00pm.
5. It will be the responsibility of each artist who enters her work to arrange transportation both to and from Convention. **No items are to be mailed prior to Convention with the exception of the Literature entries.**
6. Literature entries must be mailed to the Association of the Arts Chairman postmarked no later than April 15<sup>th</sup>. All literature must be typed, double spaced, on 8 ½ X 11 paper, 500 words or less per submittal. Entries will be judged **before** Convention.
7. Each artist is limited to two (2) entries per category.
8. Awards will consist of ribbons and certificates for First, Second, and Third places in each Division/Category and Class, and Best of Show Certificates and Trophy as determined by the Judges.
9. Judges will be selected by the Association of the Art Chairman and Committee. The judges may be member of ESA, knowledgeable in the Arts.
10. Decision of the Judges will be final.
11. Each entry will be given a tag with a number identifying the exhibitor, Chapter name and Chapter number.
12. Each entry will be judged by the tag number for anonymity. After judging and winners have been announced, name of the exhibitor will be placed on the entries.
13. If you wish your entry to be displayed to its best advantage, please provide table easels, easels, plate holders or hangers.
14. Graphics, paintings, drawings, calligraphy and photographs must be framed or matted, ready for exhibit.
15. Items not claimed by the close of Convention become the property of the State Council. Items are to be picked up by times designated by the Chairman.
16. Although security precautions will be enforced, please remember that we are not covered by Casualty Insurance should damage or theft occur.
17. One entry form per exhibitor, with number of items per category checked, accompanied by the established entry fee per item.
